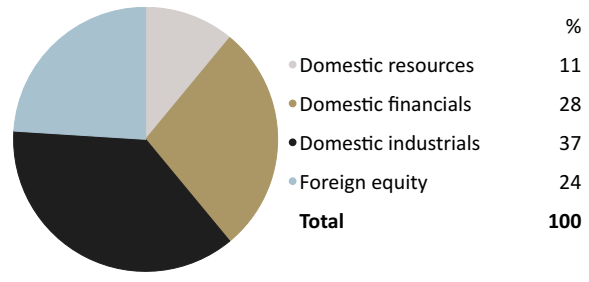
### INVESTMENT OBJECTIVE

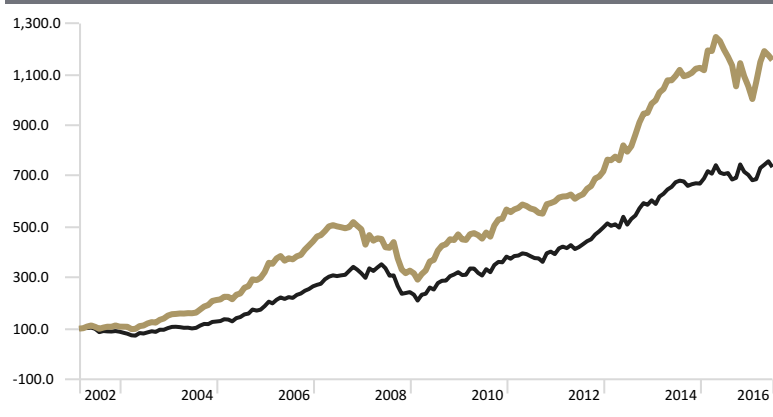
### ASSET ALLOCATION



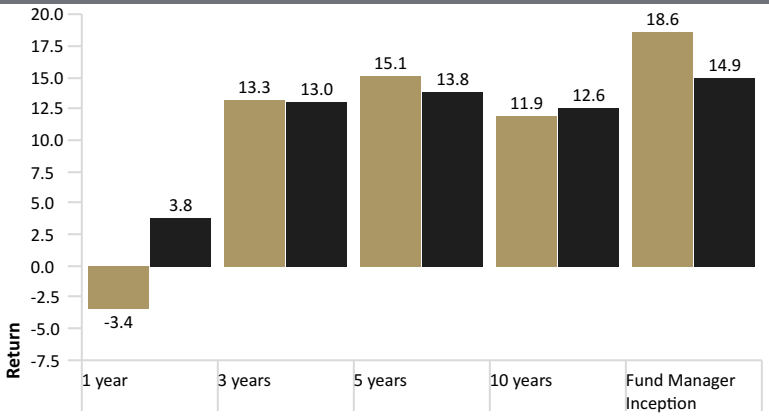

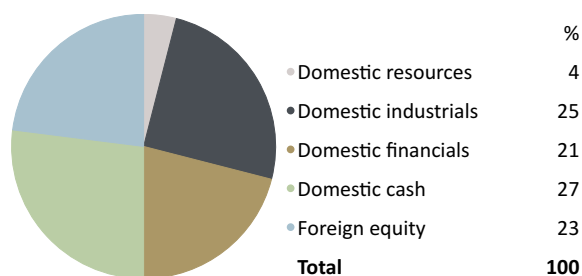

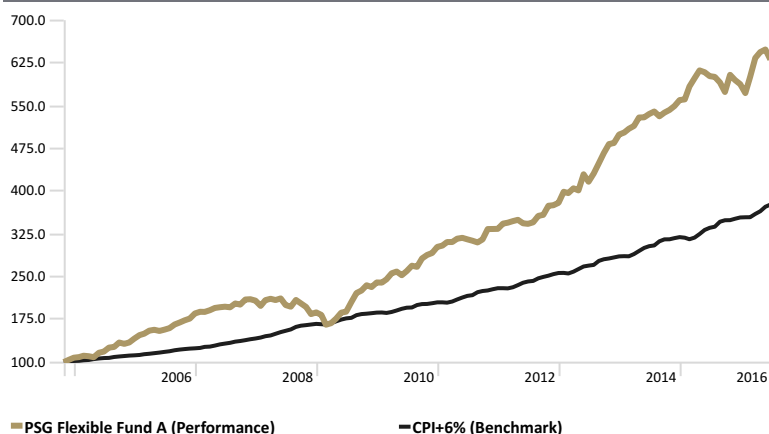
### ASSET ALLOCATION



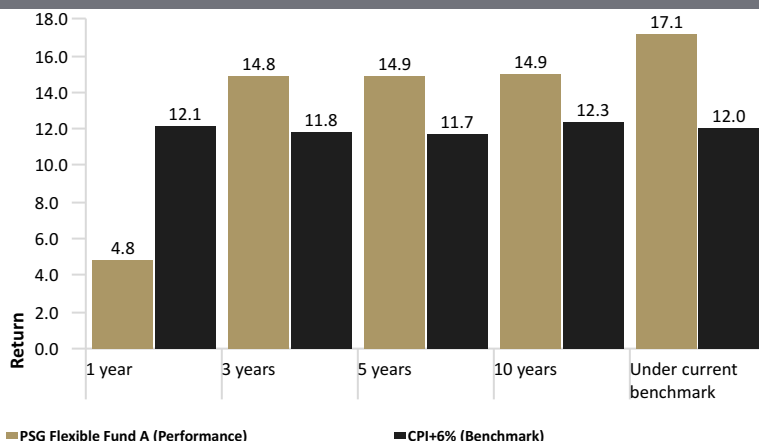

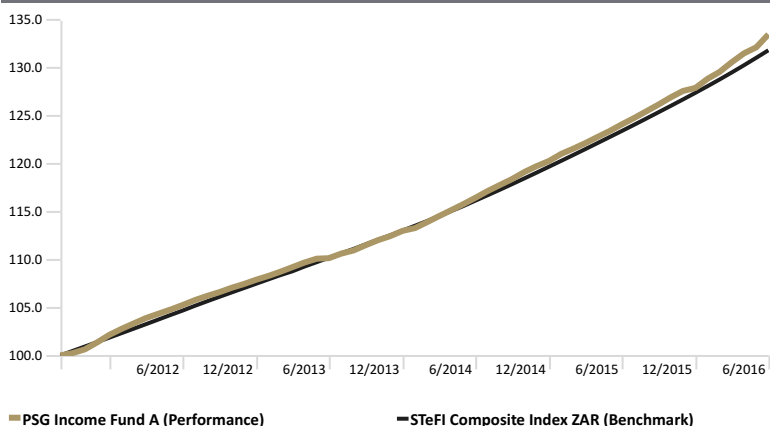

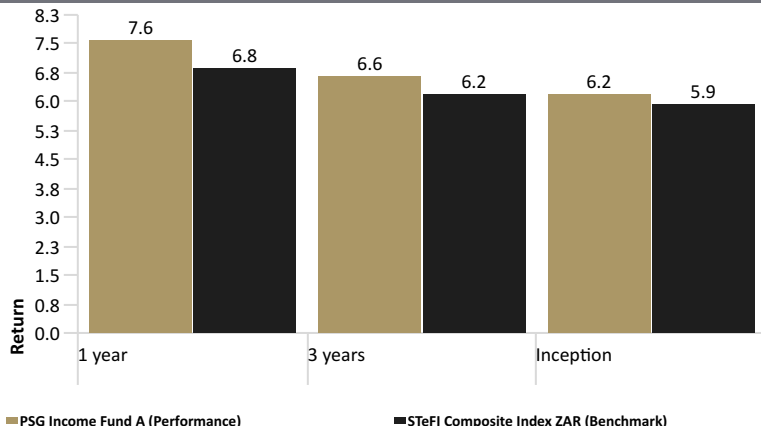

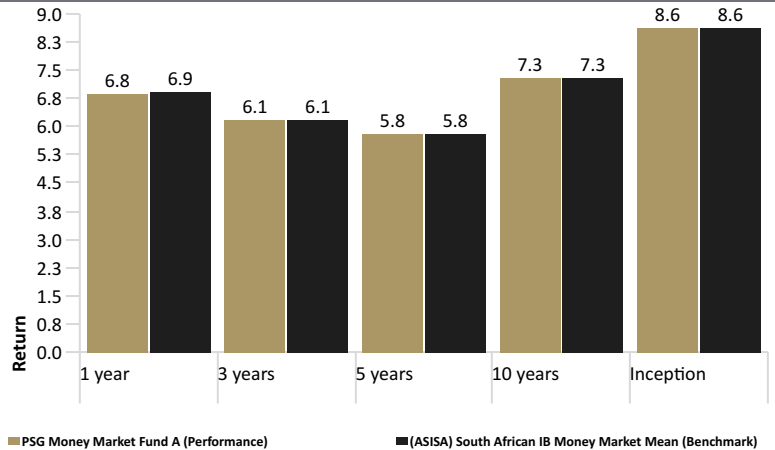

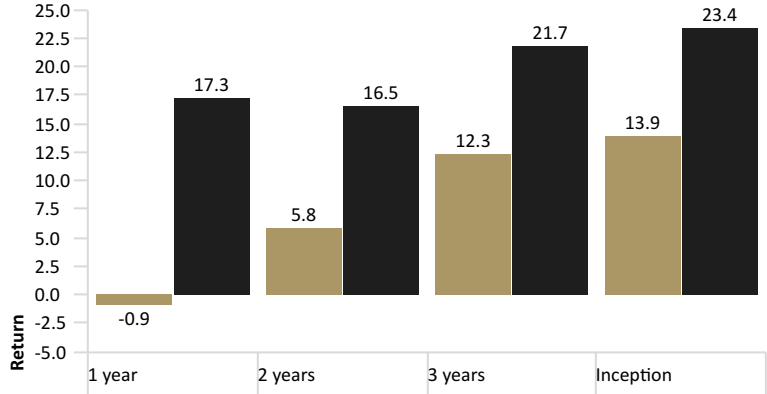

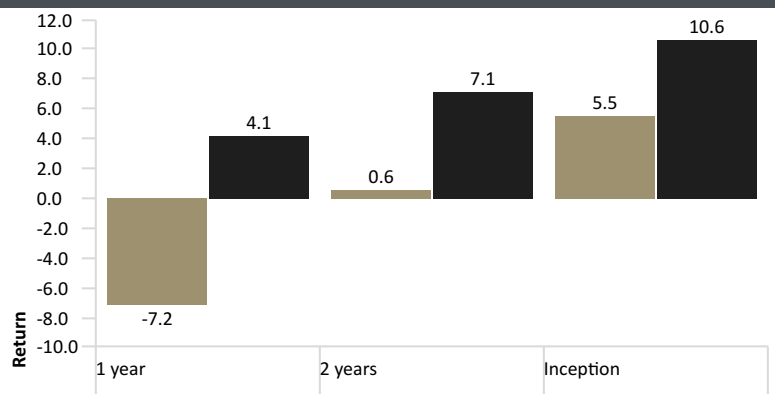
