

- Use this form to register a collateral cession of a PSG Wealth Endowment or a PSG Wealth Voluntary Investment Plan.
- The investment will be ceded as collateral, meaning that there will be a restriction on the cedent's ability to transact on the units that are ceded.

Once the cession is registered:

- the cedent (current investor) will not be able to transact on the ceded units unless written consent has been provided by the cessionary.
- the cessionary's rights will be given preference over the rights of the cedent's nominated beneficiaries if the cedent passes away.
- PSG may provide information about the ceded portion of the investment to the cessionary.
- if the cessionary requests a withdrawal, PSG will sell the units and pay the cessionary the amount indicated in this form. PSG is not required to give notice of the withdrawal to the cedent.
- the market value of the ceded units may fluctuate because the performance of the underlying investments cannot be guaranteed. PSG will not be responsible to either party if the market value of the ceded units falls below the value agreed to in this form.

To register the cession, you must provide the following documents with this form:

- a resolution of the directors, members or trustees appointing the authorised signatory, if either the cedent or the cessionary is an entity.
- a signed letter on a letterhead listing the authorised signatories, if either the cedent or the cessionary is a bank.
- proof of identity of their authorised signatories, if either the cedent or the cessionary is an entity or a bank.
- proof of identity of cessionary, if cessionary is an individual.

The cedent must ensure that the investment may be ceded and that the investment is not already subject to a cession in favour of another party.

PSG is not a party to the cession agreement and does not accept responsibility for its validity. PSG does not take responsibility for any loss or damages resulting from breach, by any party, of the terms and conditions of the relevant investment and those set out in this form.
