In order for the cession to be registered, you must provide the following documents with this form:

- the application form for the relevant product completed by the cessionary, with the supporting FICA documentation
- a resolution of the directors, members or trustees appointing the authorised signatory (if either the cedent or the cessionary is an entity)
- a signed letter on a letterhead listing the authorised signatories (if either the cedent or the cessionary is a bank)

The cedent must ensure that the investment can be ceded and that the investment is not already subject to a cession in favour of another party.
