

Conflict of Interest Disclosure

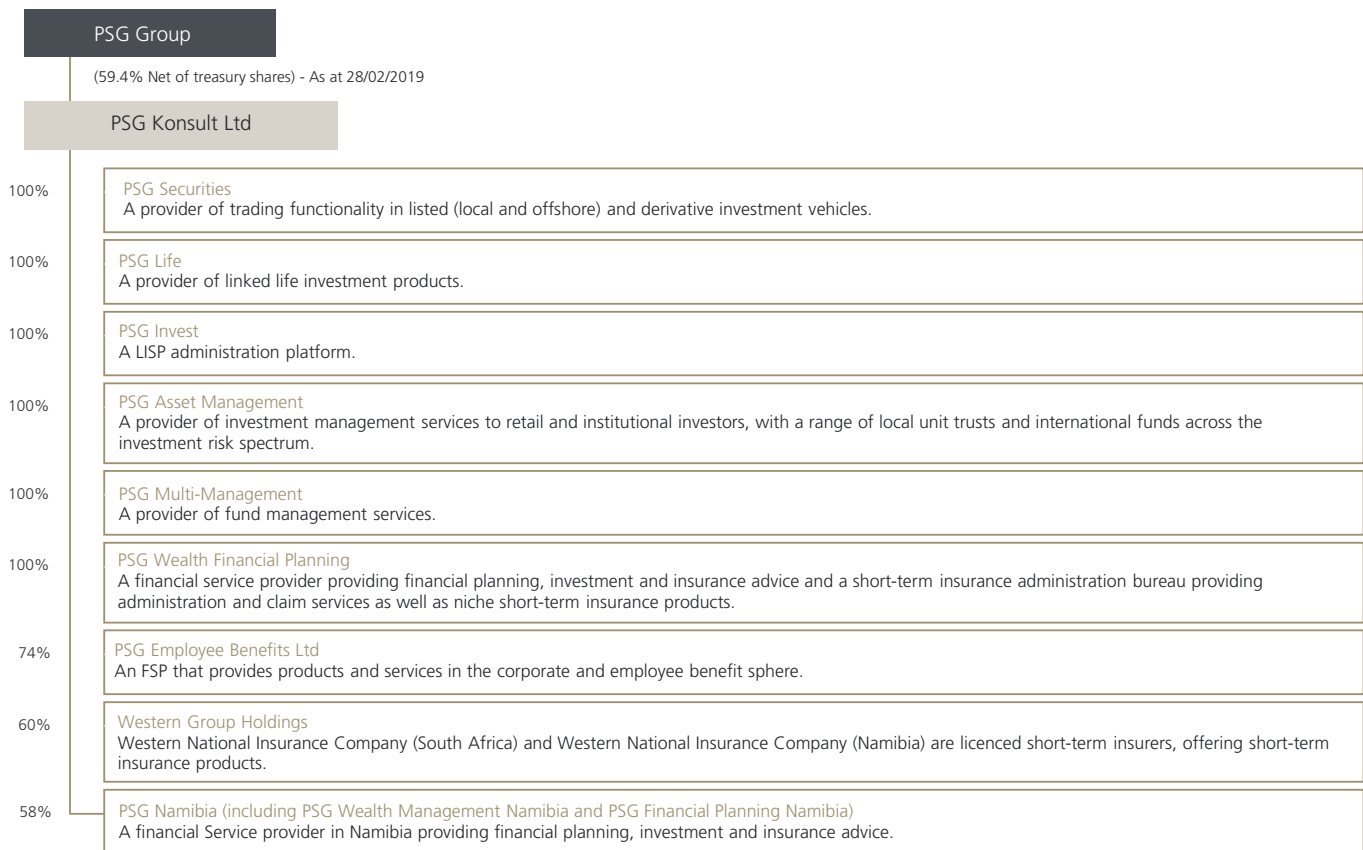
