

Investment objective (Summary of investment policy)

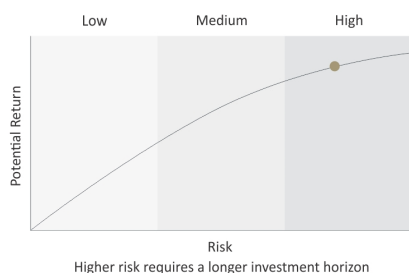
The PSG Wealth Creator Fund of Funds' investment objective is to achieve capital growth over the long term. Income is not the main objective. Investments will, apart from cash in liquid form, mainly consist of investments in equity markets (no more than 95%) via participatory interests in Collective Investment Schemes. The asset allocation will be actively managed to reflect the investment manager's view of the relative attractiveness of cash, fixed interest, equity portfolios and property markets.

Who should consider investing?

Specific Fund Risks: The fund sits at the top end of the risk/reward spectrum and investors should be comfortable with fluctuations in shares on stock markets and be prepared to accept the risk of capital loss. The portfolio is primarily invested in local and foreign equities. Equity valuations can be very volatile, especially over the short term. Property shares may be included in the portfolio which can carry the same risk as investing directly in real estate and is subject to economic and political conditions, interest rates and tax considerations. Offshore securities expose the portfolio to currency risk and currency movements may adversely affect the value of your investment. Investments may be concentrated in specific countries, geographical regions and/or industry sectors and may mean that the resulting value may decrease whilst portfolios more broadly invested might grow.

- are seeking long-term wealth creation
- want exposure to equity markets and are comfortable with stock market fluctuations
- have a long-term investment horizon of at least five years

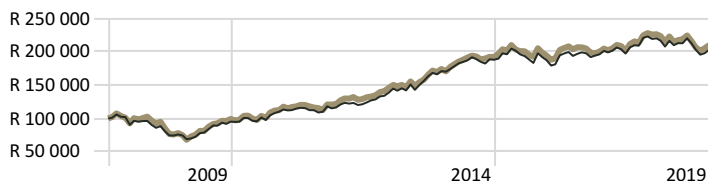

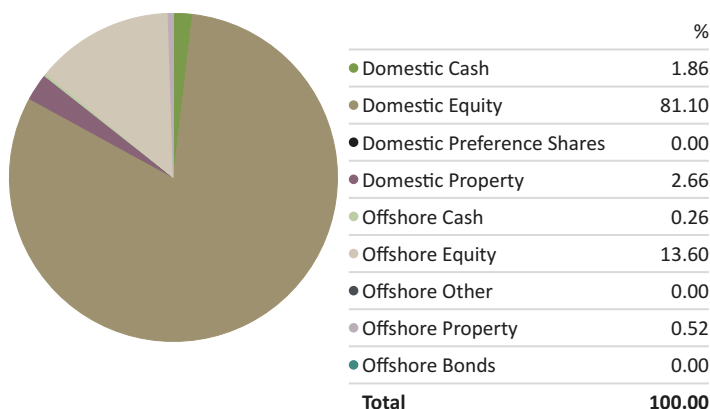
Cumulative long-term performance

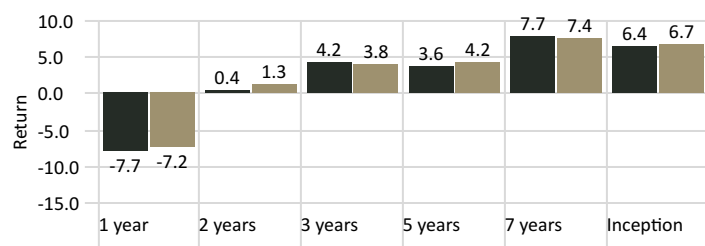

Annualised returns % (after fees)

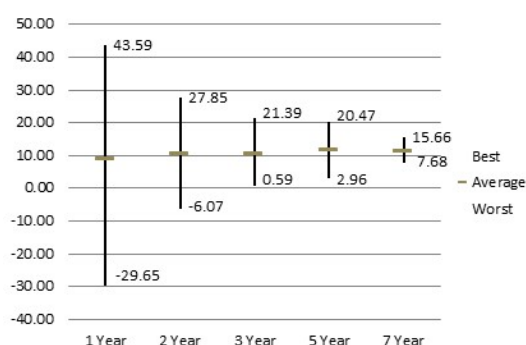

Performance

All performance data for a lump sum, net of fees, includes income and assumes reinvestment of income on a NAV to NAV basis. Annualised performances show longer term performance rescaled over a 12-month period. Individual investor performance may differ as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax. Performance is calculated for the portfolio and individual investor performance may differ as a result thereof. The portfolio is valued at 15h00 daily. Income distributions are net of any applicable taxes. Actual annual figures are available to the investor on request. Pricing

Forward pricing is used. Unit trust prices are calculated on a net asset value (NAV) basis, which is the market value of all assets in the Fund including income accruals less permissible deductions divided by the number of units in issue.

What is a total expense ratio?

The Total Expense Ratio (TER) is the annualised percentage of the fund's average assets under management that has been used to pay the fund's actual expenses over the past three years. This percentage of the average Net Asset Value (NAV) of the portfolio was incurred as charges, levies and fees related to the management of the portfolio. A higher TER ratio does not necessarily imply a poor return, nor does a low TER ratio imply a good return. The current TER cannot be regarded as an indication of future TERs. Part of the Annual Management Fee is payable to the financial intermediary. The sum of the TER and transaction costs is shown as the Total Investment Charge. Since fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. Due to rounding, numbers presented throughout this document may not add up precisely to the totals provided.

Transaction costs
